#### Chapter - I - Terms & Conditions

# **SECTION I: INVITATION FOR BIDS (IFB)**

- 3. Date of submission of bids and opening of bids
  - a. Last date for submission of bids on November 11, 2022 up to 1000  $\,\mathrm{Hrs}$
  - Bids will be opened on November 11, 2022 at 1500 hrs at Embassy of India, Seoul.

### SECTION II: INSTRUCTIONS TO BIDDERS

# 1. Delivery period / Timelines

The works must be completed within 07 (seven) days.

# 2. Order Placements and Release of Payment

The Purchase Order and payment shall be processed by: Head of Chancery, Embassy of India, Seoul.

# 3. Amendment of Bidding Documents

At any time, prior to the deadline for submission of bids, EoI, Seoul may, for any reason, whether on its own initiative or in response to the clarification request by a prospective bidder, modify the bid document.

# 4. Earnest Money Deposit (EMD)

The tender documents must be accompanied by Bid Securing Declaration. Bid Securing Declaration should be submitted in the sealed envelope. Bids submitted without BSD will stand rejected.

### 5. Period of validity of bids

Bids shall be valid for a minimum 180 days from the date of submission of bids.

#### 6. Submission of bids:

The Bid shall be neatly arranged, plain and intelligible. They should not contain any terms and conditions, printed or otherwise, which are not applicable to the Bid. The conditional bid will be summarily rejected. Insertions, postscripts, additions and alterations shall not be recognized, unless confirmed by bidder's signature.

#### 7. Late Bids

Any bid inadvertently received by EoI, Seoul after the deadline for submission of bids, will not be accepted and returned unopened to the bidder.

# 8. AWARD OF CONTRACT Award Criteria:

a. Eol, Seoul shall award the contract to the eligible bidder whose technical bid has been accepted and determined as the lowest evaluated commercial bid.

- b. The lowest price criteria shall be applied on the total.
- **9.** Purchaser's Right to amend Scope of Work If, for any unforeseen reasons, EoI, Seoul is required to change the Scope of work, this change shall be acceptable to the bidder without change.
- 10. Interpretation of the clauses in the Tender Document / Contract Document in case of any ambiguity/ dispute in the interpretation of any of the clauses in this Tender Document, Eol's interpretation of the clauses shall be final and binding on all parties.

# SECTION III: SPECIAL CONDITIONS OF CONTRACT (SCC)

#### 1. Prices

- The price quoted shall be considered firm and no price escalation will be permitted.
- b. All items are to be quoted only in English primarily or in Korean.

#### 2. Taxes and Duties:

a. The work will be exempted from payment of VAT.

### 3. Force Majeure:

EOI may consider relaxing the penalty and delivery requirements, as specified in this document, if and to the extent that, the delay in performance or other failure to perform its obligations under the contract is the result of an Force Majeure. Force Majeure is defined as an event of effect that cannot reasonably be anticipated such as acts of nature (like earthquakes, floods, storms etc.), acts of states, the direct and indirect consequences of wars (declared or undeclared), hostilities, national emergencies, civil commotion and strikes at successful Bidder's premises
